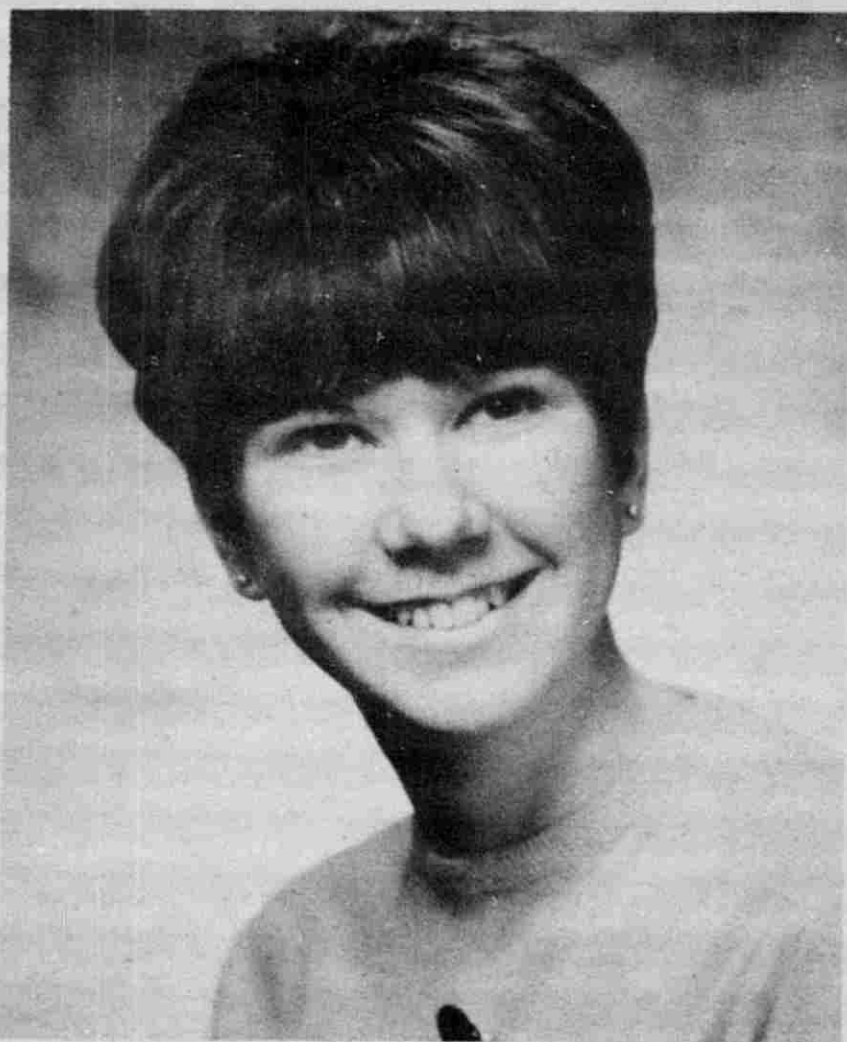


Jerry Ann Vanden Heuvel to wed
